Elisabeth Eljuri is an Independent arbitrator and founded her own firm in 2020. Since then, Ms. Eljuri has been sitting as arbitrator in numerous international arbitrations related to Latin America and filed under the rules of ICSID, the ICC, the ICDR, UNCITRAL and the LCIA. Ms. Eljuri is a member of the International Court of Arbitration of the ICC in Paris. She is also included in the Energy Arbitrators List (EAL) of the ICDR, and the lists kept by the ICC, LCIA and various arbitrations centers in Latin America such as AmCham Peru. In addition, she is part of the EAL Review Committee and of the Users Council of SIAC. Ms. Eljuri is a fellow of the Chartered Institute of Arbitrators (CIARB).

Chief Negotiator & Chief Legal Counsel of Westlawn Americas Offshore, an oil and gas company which focuses on the Americas offshore basins, including the Gulf of Mexico, Latin America and the Caribbean.

She then joined the Executive Team in January 2016 and continued advising during the entire growth of the company up until the successful exit in 2019, where she was co-responsible for the negotiation and execution of the Share Purchase Agreement with the purchaser group.

Head of Latin America for the Firm globally, reporting to the Firm's CEO. Ms. Eljuri was also a senior partner of the Firm, active in the areas of international arbitration, energy and natural resources and projects/infrastructure. She joined as an equity partner in May 1998, where she co-founded the Caracas office, became Managing Partner and later on held several positions in the Firm, including as a member of the Executive Committee of Canada and Latin America.

For many consecutive years up until her retirement from law firms, Chambers Global and Who's Who Legal in several different areas of practice ranked Ms. Eljuri as one of the top lawyers in Latin America and Star Individual for Venezuela. On the disputes side, Who's Who in Commercial Arbitration ranked Ms. Eljuri for several years as a leading arbitration lawyer internationally. Who's Who in Oil and Gas consistently included Ms. Eljuri in the list of top ten oil and gas practitioners globally.

In Latin America and Venezuela in particular, Ms. Eljuri focused on corporate and transactional work involving high-end sophisticated transactions for Fortune 500 corporations as well as international dispute work related to international investments. She has significant M&A experience and over the past nearly 30 years of practice, in addition to her contracts and general business practice, she regularly advised multinationals in their handling of political risk and protection of investments in Latin America.

Ms. Eljuri frequently acted as counsel in international arbitrations, including ICC and ICSID cases as well as domestic arbitrations in Latin America. She was also retained as independent expert in several international arbitrations or proceedings and spoken/published extensively in the area of disputes.
